Uniform Commercial Code Funds Transfer Services Security Procedures: *Direct Call for Wire Transfer.* When wire transfer requests for \$2,500 or less are received by ArrowPointe Federal Credit Union by telephone, credit union staff will identify the Members/Joint Owner/ Authorized Person by using information you have provided in our Membership Agreement and Account Signature Card(s). When the amount of the transfer request exceeds \$2,500, credit union staff will call back to verify your identity using either the work or home telephone number provided on your Account Signature Card. At the Credit Union's discretion, ArrowPointe Federal Credit Union will perform random call-backs on wires of lesser amounts. *All other Methods.* Signature verification will be used on all wire transfer requests made in person. Please note: When completing a wire transfer request, please double check for accuracy. Wire transfers returned due to incorrect information are subject to charges.



ArrowPointe Federal Credit Union Daily Cutoff Time: All deposits or transaction are processed on the next business day if received after hours, received on a non-working day, or received in the Night Depository after the cutoff time of 10am. Our business hours are listed below by branch**

Business Day Disclosure: Our business days, listed above, do not include holidays. Our Night Depository is opened around 10:00am daily. Deposits made after 10:00am or on a day we are not open will be processed on the next business day.

Daily Cut Off Time for Uniform Commercial Code Funds Transfers (Wire Transfers): Any dollar amount may be transferred until 2pm on a business day. Any request for a transfer after 2pm will be sent the next business day.

Electronic Funds Transfer Services: Daily limits on transactions are \$600 at ATMs and \$600 at Point of Sale terminals except as otherwise limited in your Membership Agreement. Point of Sale transactions are limited to ten (10) per day. Networks available for EFT Transactions: ACCEL/EXCHANGE/STAR/PLUS/VISA Fees may apply to EFT transactions (see below)
